

1. Curriculum and Syllabus is need based.



 $2. \ \mbox{The contents}$ of the course are in conformity with the learning outcomes.



Response: 55.6% of the faculty members believe that content of the courses is in conformity with the learning outcomes.



4. The curriculum has the potential in developing the habit of self learning among the students. ^{27 responses}




Response: 44.4% of faculty members had neutral response towards the potential developing characteristics in curriculum among students

5. The curriculum development procedure needs improvement.






Response: 44.4% faculty members agreed that curriculum focuses on skill development.


7. The evaluation methods mentioned in the syllabus are sufficient for providing proper assessment.

Response: 59.3% faculty members among 27 respondents found evaluation methods in syllabus provide proper assessment.





10. The course enhanced my knowledge in the subject area. ^{27 responses}




Response: 37% faculty members believed that course content had enhanced their knowledge.



11. I have the freedom to adopt new teaching techniques and tools.



12. I can contribute in curriculum and syllabus revision through proper forum.


